Payment Policies

- Securing a date: A \$175 deposit is required to book your wedding date. Your date will be secured once the signed contract and deposit are received. Advanced booking is strongly encouraged.
- A payment of 50% of invoice total is due 4 months prior to service date.
- Final Payment is due 2 months prior to service date.
- Payments made later than 14 days past due may result in termination of contract unless other payment arrangements have been discussed and agreed upon.
- All payments can be made by one source via credit card only. (unfortunately, payments cannot be split between bridal party.)
- Any last-minute services that can be accommodated on the day of the wedding will need to be paid for by that person(s) before starting said service.
- Bride is responsible for parking fee and or lodging if needed for longer travel times or early start times.
- 20% Gratuity is added to all invoice totals.
- Additional travel fee of \$125 will apply to both holiday weekends and Sunday weddings for in salon, and on-site locations due to increased traffic, and hotel rates.
- All Payments are non-refundable but may be transferable to another date if available.

Cancellation Policies

- Any contract or service changes including cancellations, must be made in writing for everyone's records. No changes will be made over the telephone.
- Changes to services may be made to the final invoice up to 3 months prior to service date. Any changes made after 4 months prior to service date will not be refunded. This allows enough timing to schedule the appropriate number of stylists/make up artists needed.
- You may email any cancellations, changes or requests to SmoothWeddings@Yahoo.com.

Other Policies

- A minimum of 4 hair services and/or 4 make up services are required for on-site travel.
- Day of Wedding: We require hair to be clean and dry; washed the night before and air dried is preferred. If hair is wet and needs to be blow dried, your scheduled turn may be skipped, and additional cost will apply.
- Late Arrivals: We ask you to have ALL bridal party members on time. Tardiness results in scheduling and service conflicts for the following wedding party members.
- Photography: (this is not a requirement) We kindly ask for several professional wedding pictures to use for our wedding portfolio. Any pictures of the couple, bridesmaids, bridal party, and any detailed shots of hair and make up.
